Sub: Construction of Toilet at Kohinoor Mills No. 1 & 2

National Textile Corporation Limited (W.R.), Mumbai is inviting sealed offers from reputed Contractor / parties for Construction of Toilet, Labour with materials at Kohinoor Mills No.1 & 2. As per the detailed specification given in Financial Bid - **Annexure 'A'**.

Eligibility Criteria:

1. Pan card and Vat & service Tax registration.
2. Experience in At least one civil work.(Submit work order)

SCOPE OF WORK:-

Providing and constructing toilet room, with double brick wall three sides and single brick wall front side with fiber glass door, plastering the walls from inside and outside, Aluminum Louver should be provided at one side on room, white glazed tiles on flooring.

White wash basin along with drain line is to be fitted inside the room 1/2" U PVC pipe water connection with brass tap to toilet & washbasin from nearest water pipe line as directed.

Earnest Money Deposit (EMD)

The Bidder should submit an EMD of Rs. 10,000/- (Rupees Ten Thousand only) in form of Demand Draft drawn from any Nationalised Bank / Scheduled Commercial Bank (Except Co-Operative Bank), in favour of **"National Textile Corporation Ltd. - Unit-Western Region"** payable at Mumbai.

Security deposit.

1. EMD of successful bidder will be converted into Security Deposit and will be return after completion of work successfully and shall not carry any interest.
2. If lowest quoted party is register with MSME and not submit EMD, have to submit same EMD amount by DD within 7 days from the date of LOI. Detail work order will be issued after paying Security Deposit.
3. EMD of unsuccessful bidder will be return after finalization of contract and shall not carry any interest.

- The tenders with fill up quotation are to be submitted in prescribed format only. Conditional tender will be rejected out rightly.

Tenders will be opened on **22.06.2017 at 03.00** PM in the presence of bidders who remained present.

Concession/Exemption for EMD for MSEs Entrepreneurs

The bidder has to specify whether they are Micro or Small Enterprises and if so, whether they are owned by SC/ST Entrepreneurs. For granting the MSEs necessary concession / exemptions as per Govt., directives, please submit the copies of registration certificates issued by the Concerned Authorities.

PAYMENT TERMS:

1. No advance payment shall be made.
2. Payment will be released after completion of satisfactory work and Bill certified by Security officer/Engineer of Corporate Office.

PERIOD OF COMPLETION

The entire job should be completed within 20 days from the date of confirmed order.

CERTIFICATION OF WORK

The contractor has to carry out the job as per the instruction of Engineer at Corporate office and Security Officer. After completion of job satisfactorily, submit the bill in duplicate along with attendance of your worker engaged for same job. Bill will not be accepted unless & until you submit above documents along with the Bills. The bills duly certified by Engineer at Corporate office and Security Officer of the mills.

Terms & Conditions:

1. **Demand Draft for EMD should be drawn from Nationalised / Scheduled Commercial Bank. The tender will be rejected out rightly if Demand Draft of CO-Operative Bank.**
2. The interested parties are requested to visit the site and understand the work before submission of tender on any working day between 10.00 am to 5.00 p.m., you may contact our Engineer at Corporate office Shri P.A.Rane, Mob.No.9969014437 for any clarification.
3. The contractor will take all necessary precaution to prevent any damage to the property of the mill. If any damage caused during the course of work will be repair the damage at your own cost on priority basis otherwise the repair cost will be recovered from your bill.
4. Debris & Salvage materials arising out of dismantling work shall be removed from the site and stacked in the mills premises as directed by mill Authority / Engineer.
5. The Contractor will use your own tools & tackles and work force.
6. The Contractor will be responsible to keep the materials i.e. the tools, tackles and materials etc., brought for the said work in your safe custody.
7. The Contractor will abide by the all the labour rules & regulations as applicable from time to time.

8. PF/ESIC will be deducted as per prevailing rules if applicable.
9. Income Tax and other Taxes as applicable during the contract period shall be deducted from bill as per the rule applicable from time to time and will issue the certificate.
10. The Contractor will be in responsible to provide necessary insurance cover to your workers as may be required under the law.
11. The Contractor will be fully responsible for any compensation either for accident, injury / death or damage caused during the operation to their employees.
12. **NTC-WRO / Mill can terminate the contract at any point of time without assigning any reason thereof.**
13. Any dispute arising out of the said contract shall be subject to the Jurisdiction of Mumbai.
