1. At least one mtrs printed polyester fabric (Duly Stamped and Signed) as a part of Technical bid is required to be submitted to NTC for the said item on the Terms & Conditions mentioned.
2. The party needs to submit the samples and also they are agreed to stand by our tasting. The samples shall be evaluated by a committee consisting of NTC Officers. **Random sample shall be tested from bulk supply.**
3. Samples shall be submitted by the bidders with proper description and on non-returnable basis.
4. Signed & Stamped Tender Document; GST Certificate & PAN Card.
5. One Proof of supply of processed polyester fabric (PO/Delivery Challan/Bill) for last year.
6. **Tender Fees & EMD**
  - A) The quotations would be opened in presence of such tenderers who wish to remain present at the time of tender opening. The tenders should be accompanied with a D.D. of Rs 500 /- as Tender Fees and Rs. 5,000/- as Earnest Money Deposit in favour of "NTC Limited, Marketing Division" (Payable at Mumbai) from any Nationalised /scheduled commercial Bank(excluding co-operative bank). The same will be converted for the successful tenderers as Security deposit, which would be returned after completion of contract. The deposit amount shall not carry any interest.
  - B) Exemption of tender fee & EMD will be given only to MSME/NSIC registered bidders. However if any MSME/NSIC party becomes L1 party, they have to submit a DD of Rs 5,000/- as security deposit within 10 days of issuing work order.
  - C) The parties whose earlier security deposit is lying with NTC are also required to submit the fresh requisite EMD with this tender.
  - D) EMD is liable to be forfeited and the bid is liable to be rejected, if the applicant/Bidder withdraw or amends, impairs or derogates from the bid in any respect within the period of validity of the bid or is found to be engaged in any material suppression of fact.
  - E) EMD will be released after 90 days of completion of the order.

**GENERAL TERMS & CONDITIONS**

1. **Delivery Schedule-** The material should be supplied within 45 days after work order or as mutually agreed by the party & NTC.
2. In case of non/partial supply within stipulated period, NTC shall forward the Liquidated Damage/ Penalty to supplying if NTC receives from its buyer. Supplier shall be liable to pay the same
3. All the material / finished goods ready for dispatch at our end should be examined **100 %** for quality norms satisfaction and mending or any other touch up required should be done prior to delivery. All the material should be free of ANY Damage / Stains / Color variation free / mistakes.
4. In event of any defects / shortages in deliveries found, penalties as deemed fit by the subsidiary would be levied on the erring party
5. **The party shall deliver the finished goods to RMD Godown, Mumbai .All the cost of transportation of ready material from party premises and to our RMD Godown, ,Mumbai would be borne by Party.**
6. Date till which the bid is valid: 180 Days from the date of submission of the bid.
7. NTC shall issue purchase orders to the successful bidder for products in partial/full quantity, within stipulated/mentioned product quantity, as and when required within bid validity period.
8. In case of damage or loss of product during the transit, the said quantity of products will have to be replaced by the supplier.

The successful bidder shall arrange, secure and maintain insurance as may be necessary and for all such amounts to protect his interest and the interest of the purchaser against the risk as detailed herein. 2. The award made in pursuance thereof shall be final and binding on the parties.

3. All the disputes will be under Mumbai Jurisdiction. The venue of arbitration shall be Mumbai.
